MIGRATION OF NAME RESERVATION FUNCTIONALITY TO NEW PLATFORM

The Companies and Intellectual Property Commission, as part of its modernization strategy, has redeveloped the name reservation service.

The CIPC is experiencing slight delays in completing name reservation requests due to unplanned events while rolling out the service, and request your patience in such regard.

Some of the more important changes for customers to note are:-

- The look and feel of the CoR9.4 or Confirmation Notice of Name Reservation (applicable to both name reservation service and defensive name reservation service) – example attached.
- 2. Look and feel of CoR9.5 or Notice Refusing Name Reservation (applicable to both name reservation service and defensive name reservation service) example attached.
- 3. More accurate user search of proposed names.
- 4. Reference Numbers/Tracking Numbers will begin with either a 9 or 6.
- 5. Reference Numbers/Tracking Numbers will be usable across other services that use name reservations as an input e.g. new company registration and company name changes.
- 6. When contacting CIPC for assistance, the reference number for the transaction as well as the customer ID / passport and e-mail address are required.
- 7. The mailbox namereservationsandregistrations@cipc.co.za will be de-activated as from 6 March 2020. Customers submitting associated name reservations (name reservation that requires supporting documents) are required to submit such name reservation and supporting documents via www.cipc.co.za / online transacting / new e-services. Customers that submitted applications via email namereservationsandregistrations@cipc.co.za (associated name reservation) SHOULD not resubmit such application via the new e-service offering, since it would result in the application being billed more than once.
